


The disAbility MegaConference will be back in 2023!

MISSISSIPPI COUNCIL ON DEVELOPMENTAL DISABILITIES

<u>Applications for Membership to the Mississippi Council on Developmental</u> <u>Disabilities Available Now!</u>

Are you ready to join a group of advocates focused on improving the lives of people with developmental disabilities? Are you a person with a developmental disability, parent, immediate relative, guardian, or non-governmental agency or non-profit organization leader? The Mississippi Council on Developmental Disabilities is accepting applications to be considered for a Governor's appointment to the Council.

The Council currently has 24 members. At least 60% of our membership are people with developmental disabilities, parents, guardians, or immediate family members of children or adults with developmental disabilities. Major responsibilities of a Council member include: attending and participating in quarterly Council meetings; actively serving on one or more committees; and reviewing grant proposals and applications to achieve five-year state plan goals.

Quarterly Council meetings are held in January (South Mississippi), April (Jackson area), July (North Mississippi), and October (Jackson area). Review of grant proposals and committee meetings occur an additional one or more times per year. Council member travel expenses are reimbursed. Two Grant Opportunities Available Now!

The Mississippi Council on Developmental Disabilities currently has two grant opportunities available for Mississippi's public, private, non-profit, or for-profit organizations and agencies! Projects should provide new ideas to improve the self-determination, independence, productivity, integration, and inclusion of people with developmental disabilities. Examples include developing self-advocacy and leadership skills; demonstrating new approaches or access to community services, such as employment, transportation, housing, health, education, early intervention, recreation, and other supports; or providing resources to families to plan for the future care of aging adults with developmental disabilities.
